



## Healthcare Professional to EMT Course (HCP2 EMT)

August 2022

This custom-built, approximately 56 hour course, will prepare the current Healthcare Professional (LPN, RN, RT, MD, DO, PA, NP) to become an Emergency Medical Technician. Students who successfully complete this course will be eligible to sit for the National Registry of Emergency Medical Technicians (NREMT) practical and written exams. This course is presented in a three-part format, with online pre-course component (3 weeks), in-classroom accelerated portion (7 days), and clinical rotation (available up to 6 months, or until minimum EMS patient contact requirements are met). Clinical rotations can be arranged through NH+C EMS or contracted with your local EMS provider. This course follows the same NREMT and NHTSA Educational standards in an abridged format.

**Attendance at all in-classroom component classes is required, 1 or more absences will likely result in course failure.**

**Course Location:** In-Classroom Component Classes will be held at the Northfield EMS Station, 1600 Riverview Lane, Northfield, MN, 55057. Portions of classes may be held offsite (all within the City of Northfield) for scenario learning purposes.

**Cost:** The cost is \$1,000 (discounts available for affiliated agencies and hospital employees and their family members). **All fees must be paid in full by the first night of class – August 1<sup>st</sup>, 2022.** Cost includes tuition, e-textbook, handouts, electronic testing program fees and skills exam fees. Agencies can be invoiced. **PLEASE NOTE:** There is an additional \$9.10 fee for MDHS Background Study, \$80 NREMT Cognitive Exam fee, and individual immunization fees per your healthcare provider. Printed textbooks may be purchased for an additional \$100.00.

**Registration is required.** No walk-ins will be allowed. Course size is limited, and registrations are handled on a first-come, first-served basis. A waiting list will be established if needed.

#### Prerequisites (please read carefully):

- Current LPN, RN, RT, MD, DO, PA, or NP Licensure
- Direct healthcare role within the last year
- Current American Heart Association BLS CPR Certification (courses available through NH+C EMS Education)
- **All students must provide proof of standard healthcare provider immunizations, including, COVID-19 and Annual Influenza Vaccination, to attend NH+C Education Classes with a clinical component**
- Our program requires the student to be 18 years of age prior to the last day of class. The NREMT exam must be taken within two years after the last day of class.
